In this regard, we enclose necessary Non- applicability certificate signed by the Company Secretary of the company, for your record.

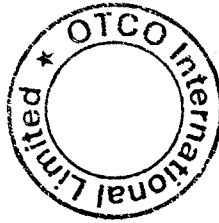
